Ingingo ya 2: Ibirebwa n'aya mabwiriza

Iki cyemezo kireba umuntu cyangwa ikigo ukora cyangwa wifuza gukora umwuga wo kwigisha amategeko y'umuhanda no gutwara ibinyabiziga ku butaka bwa Repubulika y'u Rwanda

Umutwe wa kabiri: Ibisabwa mu ishyirwaho ry'ishuri ryigisha gutwara ibinyabiziga

Ingingo ya 3: Isabwa ry'uruhushya.

Ibaruwa isaba uburenganzira bwo gushyiraho ishuri ryo kwigisha amategeko y'umuhanda no gutwara ibinyabiziga yandikirwa Umuyobozi Mukuru w'Ikigo Ngenzuramikorere iherekejwe n'urupapuro rwuzuzwa n'usaba n'inyemezabwishyu y'amafaranga y'u Rwanda 20.000 Frw yo gutegura dosiye yishyurwa kuri konti n° 1201127 y'Ikigo Ngenzuramikorere iri muri Banki Nkuru y'u Rwanda.

Isabwa ry'ubwo burenganzira rikorwa n'uwifuza gushinga ishuri ryo kwigisha amategeko y'umuhanda no gutwara ibinyabiziga cyangwa umuhagarariye ufite nibura imyaka 21 y'amavuko, akagaragaza umwirondoro we na kopi y'igitabo cy'ubucuruzi (registre de commerce). Iyo ari Koperative cyangwa isosiyete bisaba urwo ruhushya bigomba kugaragaza icyemezo kibihesha ubuzima gatozi n'amategeko-shingiro yabyo.

Ingingo ya 4: Ubushobozi bw'uwifuza gutangiza ishuri.

The purposes of this Regulatory Board are to establish the functioning of Driving School and to provide for licensing process and procedure for Driving Schools.

Article 2 : Scope of application

This decision is applicable to a person or legal entity wishing to establish or operating a driving school in the Republic of Rwanda.

Chapter 2: Requirements for starting a driving school

Article 3. Applying for a License.

The letter applying for a license to start a driving school is addressed to the Director General of the Rwanda Utilities Regulatory Agency, accompanied with the application form filled by the applicant, together with a receipt of twenty thousand (20,000 Rwf) payable on RURA's Account N0.1201127, in the National Bank of Rwanda.

The license application is done by the person intending to establish a driving school, or his/her representative who shall not have less than 21years of age, he/she shall provide his full Identifications and present a copy of his/her trade register. For companies or a cooperatives, it should be legally binding (legal status) with a memorandum of association (Statute).

Article 4: The Capacity to establish a driving school.

Usaba uruhushya rwo gushinga ishuri ryigishirizwamo amategeko y'umuhanda no gutwara ibinyabiziga agomba kugaragaza ko abifitiye ubushobozi, atanga amakuru ku mubare w'abanyeshuri ashobora kwakira, umubare w'abarimu afite, umubare n'ingano z'ibyumba afite byo kwigishirizamo, umubare w'imodoka afite ndetse n'ikibuga azigishirizamo.

Ingingo ya 5: Ubushobozi bw'abarimu.

Kugira ngo ishuri rihabwe uruhushya rwo gukora rigomba kugira abarimu babihugukiwemo n'imfashanyigisho za ngombwa.

Ingingo ya 6: Ibisabwa abarimu bigisha amategeko y'umuhanda

Kugirango umuntu yemererwe kuba umwarimu wigisha amategeko y'umuhanda agomba kuba yujuje ibi bikurikira:

1. Kuba afite byibura impamya bushobozi y' amashuri yisumbuye cyangwa indi mpamyabushobozi binganya agaciro kandi yarize amategeko y'umuhanda;
2. Kuba afite ubuzima bwiza mu gutwara ikinyabiziga no kwigisha abandi gukoresha ikinyabiziga;
3. Kuba afite uruhushya rwo gutwara imodoka mu cyiciro gihwanye n'icyiciro yemerewe kwigisha;
4. Kuba azwiho ubunyangamugayo;
5. Kuba mu gihe cyose yatwaye ikinyabiziga, atazwiho gusuzugura icyemezo cyaba cyaramufatiwe mu nkiko cyangwa kuba atarishyuye amafaranga y'amande yaba yarahanishijwe;

The party applying for a license to establish a driving school must show that he/she has the required capacity, by giving information about the number of students he/she can serve, number of instructors, number of classrooms, number of vehicles and the apprenticeship field.

Article 5: Instructor's Capacity.

For a driving school to be given a License to operate, it must have well skilled instructors and all necessary syllabuses.

Article 6: Requirements for Traffic code Driving Instructor.

For a person to qualify as a traffic code instructor, he/she must fulfill the following requirements:

1. Must have at least a high school certificate of education or its equivalent and having satisfactorily completed a traffic code course;
2. Must be physically able to safely operate a motor vehicle and to train others to use motor vehicles;
3. Must hold a valid Rwandan driver's license in the same category as the one he/she is appointed to instruct;
4. Must be known as a person of Integrity;
5. Must in all his/her driving life, not be known of under looking any outstanding decision taken against him/her by any tribunal or willfully refuse to pay the fines imposed on him/her;

6. Kuba afite imyaka itari munsu ya 21.

Ingingo ya 7 : Ibisabwa Umwarimu wigisha gutwara Ibinyabiziga.

Bitanyuranije n’ibivugwa mu ngingo ya gatandatu (6),uwigisha gutwara ikinyabiziga asabwa nibura kuba afite byibuze icyiciro rusange cy’amashuri yisumbuye.

Ingingo ya 8: Ibiranga ikinyabiziga yigishirizwaho

Uwifuzwa uruhushya rwo gushinga ishuri agomba kugaragaza ibyangombwa biranga imodoka bigizwe na « carte jaune », isuku, ubwishingizi bwo gukora uwo murimo, n’icyemezo ndangamiterere y’ikinyabiziga cyigishirizwaho.

Ingingo ya 9: Imiterere y’ikinyabiziga cyigishirizwaho

Ibinyabiziga byabugenewe nibyo byemewe kwigishirizwaho gusa. Ibyo binyabiziga bigomba kuba bifite aho guhagarikira imodoka habiri (double pédales), ikinyabiziga kigomba kwandikwaho izina ry’ishuri, bikarangwa n’inyuguti ya **L** mwibara ry’ubururu kandi igomba kugaragara neza inyuma y’ikinyabiziga

Umutwe wa 2: Uburyo uruhushya rutangwa

Ingingo ya 10: Gusaba uruhushya.

Ushaka kwaka uruhushya rwo gufungura ishuri ryigisha amategeko y’umuhanda no gutwara ibinyabiziga, asabwa kuzuza urupapuro rusaba (Formulaire) akura kuri RURA cyangwa kuri site yayo.

6. Must not be less than 21 years of age.

Article 7 : Requirements for a qualified Driving Instructor

Notwithstanding the provisions of article six (6), a driving instructor must hold at least an Ordinary level (O’level) certificate of education.

Article 8: Identifications of a Driving School vehicle.

The applicant for a license to establish a Driving School must exhibit all the detailed identifications of the vehicle which include; the vehicle’s ID card, cleanliness, Driving School’s Insurance, and Certificate of inspection.

Article 9: The conditions of the teaching vehicle

Only vehicles manufactured for training purposes shall be allowed. Those vehicles must have the halting pedals on both sides (double clutch system), each vehicle must be labeled with the name of the School, identified with a Letter « **L** » in blue colour at the rear side of the vehicle.

Part 2: License issuance modalities

Article 10: Applying for a License.

The person intending to open a traffic code and Driving School is asked to fill the application form provided by RURA or download it from the RURA’s website.

- e) Umubare fatizo w'ibinyabiziga bitari muni ya bine (4) mu Mujyi wa Kigali na bibiri (2) mu Ntara;
- f) Kuba afite icyumba cyangwa ibyumba ,ikibuga ndetse n'ibikoresho byangombwa by'Infasha nyigisho ;
- g) Inyemezabwishyu y'amafaranga atangwa n'uwemerewe gukora uwo mwuga ihwanye n'amafaranga ibihumbi mirongo itanu (50.000 frw) kuri Konti n° 120.11.27 y'Ikigo Ngenzuramikorere iri muri Banki Nkuru y'u Rwanda.
- h) Kumenyekanisha aho iryo shuri rizakorera:
- i) Gushyikiriza ikigo Ngenzura Mikorere icyemezo gitangwa n'inzego z'ibanze zimwemerera gukorera muri aho akorera.

Ingingo ya 11 : Igihe uruhushya rutangwamo

An individual or a Company applying for a license to open up a traffic code and driving school must submit the following documents:

- a) Certificate of inspection of all the vehicles to be licensed, proving their good condition;
- b) Insurance of both the instructor and the student of not less than 6 months period;
- c) Vehicle identification card;
- d) Business plan (5 years minimum)
- e) The number of vehicles for a Driving school should be at least four (4) in Kigali City and two (2) in the Provinces.
- f) He/she must have classroom(s), apprenticeship ground and all the related guiding facilities;
- g) A receipt of the license fees of fifty thousand Rwandan francs (50,000 Rwf), payable on RURA's account n° 120.11.27 in the National Bank of Rwanda;
- h) Showing full address of the school.
- i) Submitting to the Regulatory Agency the operational authorization issued by the local authorities.

Article 11 : Time to acquire a license

Iyo ibyangombwa byose bisabwa byuzuye, uruhushya rutangwa mu gihe kitarenze ibyumweru bibiri (iminsi 14) uhereye igihe dosiye yuzurijwe usaba uruhushya amaze kwishyura amafaranga yarwo avugwa mu ngingo ya 10 (g). Iyo Uruhushya rudatanze muri icyo gihe, Ikingo Ngenzuramikorere kigomba kumenyesha uwarusabye mu nyandiko, impamvu z’ubwo bukererwe.

Ingingo ya 12 : Ibigize uruhushya

Uruhushya rugaragaza uruhawe, igihe rumara, ibyo agomba kubahiriza n’ibihano biteganywa.

Ingingo ya 13: Ibiciro bikoreshwa.

Ikigo Ngenzuramikorere nicyo cyemeza uburyo amafaranga y’ishuri yishyurwa n’abiga amategeko y’umuhanda no gutwara ibinyabiziga bariha.

Uburyo amafaranga y’ishuri agenwa bushobora kuvugururwa n’Ikigo Ngenzuramikorere igihe bibaye ngombwa.

Ingingo ya 14 : Inyandiko zibikwa

(a) Umuntu wese wahawe uruhushya rwo kwigisha amategeko y’imihanda no gutwara imodoka, agomba kubika inyandiko zerekana ibi bikurikira :

1. Izina, umwirondoro na numero y’uruhushya yahawe rw’ishuri;
2. Izina n’umwirondoro wa buri munyeshuri wize muri iri shuri;

When all the requirements for the license are available, the license is issued within two weeks (14 days) from the submission of a valid and complete application for a license and provided that the applicant has first paid the license fee provided for in article 10 (g). If a license is not issued within that time, RURA shall inform the applicant in written the reasons for delayed issuance.

Article 12: License Components.

The license shows the licensee, its time value, the licensee’s binding obligations and penalties for failure to comply with the license obligations.

Article 13: Driving school scholarship.

The Regulatory Agency shall approve the Driving School Scholarship structure.

The scholarship structure may be revised from time by RURA.

Article 14: Records of Licensee

(a) Every licensed operator must, under this Decision keep a record of the following information:

1. The name, details and the license number issued to the school;
2. The name and details of students that studied in the school;
